- 2) No refunds. I understand that my dues and MLS fees are non-refundable. If I fail to maintain eligibility for Membership or for MLS Services for any reason under the bylaws or MLS rules, including but not limited to discipline by the Association/MLS, I understand I will not be entitled to a refund of my dues or fees.
